Detailed Terms & Conditions

Earnest Money Deposit

- 1. The party shall be required to deposit 5% Earnest Money of estimated value of rate quoted in Annexure "A" by way of Bank Draft/Fixed Deposit Receipt/Bank Guarantee drawn in favour of 'Managing Director, Kerala State Co-operative Consumers' Federation Ltd.'
- 2. The Tenderer may submit a request for treating the amount due to them from Consumerfed as Earnest Money Deposit and Consumerfed have full right to accept / reject the request. This request may be accompanied along the tender document by the tenderer.
- 3. EMD furnished by all unsuccessful tenderers shall be returned to them without any interest whatsoever, at the earliest after expiry of the final tender validity period but not later than 30 days after conclusion of the contract. EMD of the successful tenderer shall be returned, without any interest whatsoever, after receipt of performance security from it as called for in the contract.
- 4. The firms / institutions / Tenderers those who are exempted from Earnest Money Deposit should produce necessary government orders for the same.

Terms & Conditions

- 1. The validity period of this tender is for 30 days.
- 2. The Party should submit the quotation for renewal license for 150nos and also new purchase of license for 202nos.
- 3. Acceptance of the tender constitutes a concluded contract. Nevertheless, the successful tenderer must within a fortnight/a month after the acceptance of his tender furnish 5 per cent of the amount of the contract as

- security deposit and execute an agreement at his own cost for the satisfactory fulfillment of the contract, if so required. This security deposit shall be released on successful completion / execution of the order. The firms / institutions / Tenderers those who are exempted from Security Deposit should produce necessary government orders for the same.
- 4. Withdrawal from the tender after it is accepted or failure to supply within a specified time or according to specifications will entail cancellation of the order and purchases being made at the offers expenses from elsewhere, any loss incurred thereby being payable by the defaulting party. In such an event the Consumerfed reserves also the right to remove the defaulter's name from the list of suppliers of Consumerfed for the next two years.
- 5. Any Tender received after the time fixed on the due date is liable to be rejected.
- 6. The tenders shall be opened in the presence of the tenderers or his authorized representatives. The tenderers representative shall furnish the authorization letter of the concerned authority to participate in the tender.
- 7. No advance payments shall be made. Full payments will be made to the vendor after delivery and proper installation of the software
- 8. The rates quoted should be for delivery of the articles at the Head Office.
- 9. Installation, testing, commissioning of the software has to be carried out by Technical experts of the company/supplier up to the satisfaction of user department
- 10. The Vendor/ Party is liable to deliver onsite and remote technical support during the validity period of license without any failure.
- 11. Special conditions, if any, printed on the quotation sheets of the tenderer or attached with the tender will not be applicable to the contract unless they are expressly accepted in writing by Consumerfed.
- 12. Any attempt on the part of tenderers or their agents to influence the Officers concerned in their favour by personal canvassing will disqualify the tenderers.

FORCE MAJEURE

If the Maintenance Agency is unable to comply with the provision of the contract or creative delays due to reason of Force Majeure such as acts of god, acts of public enemy, acts of Government, fires, floods, earthquake, epidemics, restrictions, strikes and freight embargoes, the maintenance agency shall immediately inform Consumerfed in writing of his inability. The Consumerfed in receipt of such notice after certification if necessary, may agree to the same as may be reasonable but without prejudice to other terms and conditions of the contract

FORCE MAJEURE

If the tenderer is unable to comply with the provision of the contract or creative delays due to reason of Force Majeure such as acts of god, acts of public enemy, acts of Government, fires, floods, earthquake, epidemics, restrictions, strikes the tenderer shall immediately inform Consumerfed in writing of his inability. IURISDICTION

The jurisdiction for the purpose of settlement of any dispute or differences whatsoever in respect of or relating to or arising out of or in any way touching this contract or the terms and conditions there or the contraction/interpretation thereof shall be that of Ernakulam jurisdiction only.

COST DETAILS AND VALIDITY:

Prices quoted shall be in Indian Rupees, shall be firm and shall not be subject to exchange rate variations, fluctuations in price, Labour conditions and freights or any conditions whatsoever. The quoted Rate / Cost should be inclusive of all levies/ taxes like Service tax, GST, Educational cess, Sales Tax, Transportation, Customs, Excise, traveling charges etc, if any

PENALTY FOR DEFAULT IN SERVICES:


