Aspiring bidders/suppliers, who have not obtained the user ID & Password for participating in e tendering in Consumer fed, may obtain user ID & password by giving the details in the website [www.tenderwizard.com/CFED](http://www.tenderwizard.com/CFED) through link "Register Me". Alternatively any person can send a request for user ID and password through letter/e-mail to Managing Director, Head Office, Ernakulam, CONSUMERFED Bidders/Suppliers can download the e-tender form from following website [www.tenderwizard.com/CFED](http://www.tenderwizard.com/CFED).

1. Suppliers can access e-tender form upto 27.09.2024, 2.00 P.M.
2. Last date for the submission of completed tender document in the e-tender website is 2.00 P.M on 27.09.2024. All mandatory fields/spaces in the tender document or schedules should be filled up.
3. Those who are not well versed with computers and e-tendering procedures can come to the Head Office IT Section. All the required help will be provided for participating in the tender through electronic mode.
4. Suppliers can access tender documents on the website, fill them and, submit the completed tender document into electronic tender box on the website itself. Supplier should upload only the downloaded documents, without changing the name of the document. Making any modifications in the downloaded documents, except filling the required details, will lead to disqualify the supplier from the tender.
5. Exception for Tender Fee & EMD , Security Deposit:  
After verifying the submitted documents for exemption from, the tender Fee, EMD, Security Deposit issued by Central Government / State Government of Kerala, regarding MSME exemption etc., the final decision may be taken by Consumerfed in all rights.
6. After loading and submitting the quote sheet, the bidder / supplier should delete the quote sheets from the computer used by them (in case of computers of internet café or if such common shared computers are used) and clear the Recycle bin, i.e. to avoid others to see the rates quoted by you.

8. Each tender shall be accompanied by an **E.M.D. of Rs.25,000/-** (Twenty five thousand rupees only) for the supply of Thermal Paper by way of

  16. TYPE OF DELIVERY: Net Weight Door Delivery at Stipulated Destinations.
  17. **PAYMENT CONDITIONS:** 70% of the value of material would be released upon the receiving the material and satisfying the quality standards prescribed by Consumerfed and matching with the sample supplied by the supplier at the time of Purchase Committee. The balance **30%** would be **released within 45 days** after distributing the material to our production unit after ensuring quality.
  18. 19. The quoted rates will be considered firm for acceptance and **valid for 6 months from the date of agreement**. Tenders not stipulating period of firmness and tenders with price variation clauses are liable to be rejected by the purchase committee in the presence of Managing Director.
20. An Authority headed by Managing Director, Purchase Committee have all rights to finally decide on all issues relating to any grievance of suppliers against the decision of stock accepting authority at Depot Level on matters relating to quality and quantity of supply.
21. The bidders are requested to quote for the same quality, quantity and supply at specified destinations, failing which the contract will be summarily rejected.
22. Suppliers must be produced lab test certificate or warranty certificate if available /both certificate copies are submitted along with bill to the concerned depot at delivery time (if available), if required.
23. Penalty for delay in supply: When the supply is after the schedule date as given in the Purchase Order 0.5% or above per day for the total value of delayed quantity will be penalized. **Storage charges** on not accepted stock shall be **charged @Rs. 50/-per Ton per day** until the period of removal from the date of intimation of non-acceptance.
24. A refundable Security Deposit of an amount of 5% of the value of the contract will have to be remitted by the successful Bidder as Security Deposit/Performance Security in the form of DD, NEFT, RTGS, Bank Guarantee it will be refunded to the bidder after the completion of the contract. The bidder also agrees have no right to claim any percentage of interest for this performance security till the completion period of the contract.

### GENERAL CONDITIONS

1. The cost of tender form once paid will not be refunded.
2. Further clarification/corrigendum in this tender regard, if any, will be put up only on the above site. Bidders should regularly visit the above web site to keep themselves updated.
3. The eligible bidders must have GST registration and the quoted rates must be inclusive of all taxes, duties and cesses prevailing, also inclusive of, likely to be levying in future by the State Govt./Central Govt.
4. Quantities are tentative and can vary.
5. If any bidder withdraws from his tender before the expiry of the period fixed for keeping the rates for acceptance, the earnest money if any, deposited by him will be forfeited or such action taken against him as consumerfed think fit.
6. The final acceptance of the tenders rests entirely with the consumerfed, who do not bind themselves to accept the lowest or any tender. But the bidders on their part should be prepared to carry out such portion of the supplies included in their tenders as may be allotted to them.
7. If the Purchase Committee rejects the item sample of a brand or trademark submitted by the supplier that particular tenderer must be removed from the tender process without any further intimation.
8. The successful bidder shall remit a sum of equivalent to 5% of the value of the contract in the form of (Demand Draft /RTGS/NEFT/Bank Guarantee) as performance Security before signing the agreement. This will be returned the expiry of the agreement period without any interest in all respects.
9. Communication of acceptance of the tender normally constitutes a contract at the final stage. Nevertheless, the successful bidder shall also execute an agreement in required value of Stamp paper, for the due fulfillment of the contract within the specified period in the letter or e-mail intimated to you from Consumerfed.
10. The Bidder/supplier shall have to pay all stamp duty, lawyer's charges and other expenses incidental to the execution of the agreement if required.
11. In cases where a successful bidder, after having made partial supplies fails to fulfill the contracts in full, all or any of the materials not supplied may at the discretion of the consumerfed, be purchased by means of another bidder or by negotiation or from the next higher bidder who had offered to supply already and the loss, if any, caused to the consumerfed shall thereby together with such sums as may be fixed by the consumerfed towards damages, be recovered from the defaulting bidder.

12. Even in cases where no alternate purchases are arranged for the materials not supplied, the proportionate portion of the security deposit based on the cost of the materials not supplied at the rate shown in the tender of the defaulter shall be forfeited and balance shall be refunded.
13. If the contractor fails to deliver within the time/period(s) specified in the contract, the **consumerfed** shall without prejudice to its other remedies under the contract, deduct from the contract price as liquidated damages, a sum equivalent to **1%** of the delivered price of the delayed or unperformed services for each week of delay until actual delivery or performance, up to a maximum deduction of **10%** of the contract price of the delayed stores or services. Once the maximum is reached, the company may consider termination of the contract at the risk and cost of the contractor.
14. The bidders will be informed by mail about award of the contract. In addition, the bidders can see the award of the contract under "Tender Status" and also against results of the tender option in the web site.
15. The bidder shall undertake to supply materials according to the standard sample and Specifications and should start to complete the supply from the date of supply order.
16. No representation for enhancement of rates once accepted will be considered.
17. The prices quoted should be inclusive of GST and all taxes, duties, cesses prevailing and likely to be levied from the supplier in future by the State/Central Govt., which may become payable by the supplier in future as per such laws or rules of the contract.
18. Payment will be released upon the receiving material are satisfy the quality standards prescribed by consumerfed and matching with the sample supplied by the supplier at the time of purchase committee and after getting the stock control form and original bill from Triveni Stationery Division Kunnankulam (payment period 45 days).
19. All payments to the supplier will be made by account payee Cheque/RTGS/NEFT. In case payment is required by demand draft, bank charges will have to be borne by the supplier.
20. Bad/unused/defective items will be returned for replacement.
21. Any deviation from the specification mentioned above, i.e. poor quality will attract imposition of penalty to the satisfaction of besides rejection of the item partly/entirely including forfeiture of security deposit, blacklist etc.
22. The successful bidder should also be prepared to supply additional Quantity at the same rate approved by the consumerfed, if required.
23. The firm must have GST registration and bill must contain the GST number of Consumerfed.



24. Those bidders who qualified have quoted for each item will be invited for negotiation and the qualified bidder after negotiation will be awarded the contract by the decision of Purchase Committee with the approval of Managing Director.
25. Those who are interested to comply with the terms and conditions stated above need be applied/participated in this tender.
26. Special conditions, if any of the bidders attached with the tender, such conditions will not be applicable to the contract, unless they are expressly in writing is to be not acceptable.
27. Bid Prices:-Duly filled "BOQ" file should be uploaded in the e-tender website. The bidder shall indicate in the BOQ file the prices for the supply of required items and shall upload this filled up BOQ file in the e-tender website. No hard copies of BOQ file or Bid prices should be submitted to Consumerfed offices.
28. An Undertaking to the effect that the bidder / firm has not been black listed by any PSU or any other Government agencies or restricted by any regulatory authorities from offering such services or solutions to the clients. The tender will be rejected straight-way without assigning any reasons if the firm declared black listed by any Govt./Semi Govt. department/agencies etc.
29. The Consumerfed has the right to increase or decrease quantities after awarding the bid.
30. **Signing of Contract:** -An agreement should be executed in the Kerala Stamp Paper worth as follows. **'One rupee for every 1000/- rupees** or part thereof on the amount agreed in the contract, subject to a minimum of rupees 200 and a maximum of rupees one lakh".
31. All payments shall be made from the Consumerfed Head Office. Payment shall be made in Indian Rupees (INR) only.
32. The payment will be effected within **45 days** after the completion of entire supply and producing original Tax Invoices along with original delivery notes received from the distribution center (with signature and office seal).
33. In case of any difference or dispute arises in connection with the contract the same will be decided as per the provisions contained in the Kerala Co-operative Societies Act (21 of 1969). Only the courts of Ernakulam; Arbitration Court shall have jurisdiction over disputes related to this contract.
34. The quoted price should be inclusive of all kind of taxes, duties, freight charges, expenditures for our door delivery at our Production Unit Triveni Stationery Division, Kunnamkulam, Thrissur, Kerala.

35. Delivery should be made within seven days on receipt of purchase order, work order from Consumerfed and deliver all the requirements at **Triveni Stationery Division, Kunnankulam in Thrissur District, Kerala.**
