TERMS & CONDITIONS :-

- 1.Manufacturing firm should have preferably ISO 9001 quality certificate.
2. The manufacturer should mention the number of machines sold in Kerala with customer details in the last five years and also total number of machines in Kerala.
3. Rates quoted should be inclusive of all taxes/charges inclusive of loading, Un loading, transportation and erection and installation charges.
4. Pre installation requirement including the required foundations, cabling, electrical, if any, should be intimated by the successful bidder immediately after confirmation of the supply order. Necessary layout and foundation drawings also should be furnished.
5. Spare parts, mechanical and electrical be provided.
6. The tenders should produce documentary evidence in proof of the following
 - List of Government supplies made by the firm.
 - Performance certificate from reputed customers.
7. Catalogues/ operation manuals/ spare parts manuals along with all technical details of the machine should be produced by the successful bidder, at the time of supply of machine.
8. Installation and trial run should be carried out at the suppliers cost and risk.
9. Required accessories/ spares/ tools for installation to be taken care of by the tenderer.

10. Supervisors/Operators as decided by the Consumerfed should be trained free of cost by the firm after the completion of installation.
11. The machine should have a warranty of at least one year.
12. Quotationer shall submit the quotation in single cover containing two separate sealed covers. The first cover should contain "THE TECHNICAL BID" and second cover should contain the "FINANCIAL BID". Only after the successful evaluation of the technical bid their respective financial bid would be considered.
13. During the erection/commissioning or while performing in the guarantee period, if the machine supplied is found defective, improper or not as per the specifications or of inferior quality, or is not otherwise in accordance with the contract, then the Consumerfed shall intimate this fact in writing to the supplier for rectification/replacement of such defective machines at their own cost to the entire satisfaction of the Consumerfed. In the event of their failure to do as above, Consumerfed reserves the right to carry out such repair work at their risk and cost of defaulted supplier.
14. My abnormal delay by the supplier in delivery/ commissioning etc. attract compensation and penalty by the supplier or action as decided by the Consumerfed. All the technical specification should be clearly mentioned by the tenderer.
15. Only manufacturing firms (OEMs) or their authorized dealers are eligible to participate in the tender.
16. Demonstration of the machines should be arranged by the manufacturer/authorized dealer, if needed for making a proper technical decision regarding buying.
17. The supplier shall undertake that the firm has never been blacklisted by any Government/Quasi Government firm in India and no case is pending against the firm. This should also be made clear in the tender as preliminary undertaking (as per the affidavit format enclosed to be executed in Kerala Stamp Paper worth Rs.200/-).
18. Details of the machine offered such as Brochures, drawings if any, video CDs demonstrating the operation etc. should be brought at the Pre-bid meeting and any deviation from the technical specifications should be clarified and got approved by the purchaser's technical authorities.
19. Rate quoted should be valid for a period of minimum 6 months.
20. Any document/certificate required from the Consumerfed for delivery of machines should be specified in advance.

21. Consumerfed has every right to reject the tender at any time during the tendering process if any violation of any of the tender conditions is noticed.
22. The successful tenderer shall furnish a Security Deposit equivalent to 5% of the total value of the contract rounded to the nearest rupee. The EMD and Performance Security are refundable. The Performance Security will be returned only after the warranty period.
23. The near relatives of employees of K.S.C.C.F.LTD are not eligible to participate in the tender. The relationship for the purpose will be as specified in Annexure 21 of Stores Purchase Manuel of Kerala. In addition to this mother's, sister's son/daughter shall also deemed to be relative. The scanned copy of the declaration in this regard, dully filled and signed should be submitted online.
24. 80% Payment will be made after the satisfactory receipt, instalation and commissioning of the system/machine in good condition and to the satisfaction of K.S.C.C.F.LTD. The remaining amount will be paid after receiving a satisfactory performance report.


